**BASIS**

The Kalamazoo Christian School Association is controlled by an elected Board of Trustees. Board members are parents and friends committed to training children in keeping with the teachings of the Holy Bible, as interpreted in the Reformed Standards. As a parent/guardian seeking to enroll my child(ren) in the Kalamazoo Christian Schools and to become a member of the Kalamazoo Christian School Association,

I affirm that the following Statement of Basic Beliefs and Purposes is consistent with my own beliefs:

**STATEMENT OF BASIC BELIEFS AND PURPOSES**

- I believe that God exists in three persons, namely, God the Father, who is the creator and sustainer of the universe; God the Son, who became incarnate in Jesus Christ to save sinners who believe in Him and who now rules as king of the universe and the holy universal church; and God the Holy Spirit, who was sent as the Christian’s comforter, sanctifier and guide.
- I believe that the Holy Bible is the only infallible and inspired Word of God and that it must be taught and used as the guide for the Christian’s life and conduct.
- I believe that the Word of God requires Christian parents to make every effort to train their children in the fear and nurture of the Lord and that, for this reason, the instruction of children in the school as well as in the home must be in keeping with the teaching of the Word of God.
- I believe that the right and responsibility to train children belongs to parents and that these schools depend on and belong to the parents rather than the church or state.
- I believe we must help our students understand that God summons them to honest worship, moral discipline and personal holiness, and that we must equip them for meaningful service in the kingdom of God.
- I believe that students enrolled in the Kalamazoo Christian Schools and their parents shall be associated with and regularly attend a Christian church.
- I believe that the Kalamazoo Christian School Association shall meet the academic standards of the State of Michigan, both with respect to academic requirements for faculty and administration and in terms of the basic curriculum, to enable students to contribute to the general welfare of the society in which they live.

**PARENT/GUARDIAN AGREEMENT**

- I agree that I am enrolling my child(ren) in the Kalamazoo Christian Schools primarily because of my earnest desire that my child(ren) receive Christ-centered academic training.
