Registration Contract Terms:

1. 100% of our tuition obligations will be paid according to the selected payment option.
2. FACTS account for tuition payments must be in place no later than July 25 for this contract to be valid and my child's place in a class secure.
3. If I/we cannot meet the payment plan, I/we will contact the Finance Committee of Kalamazoo Christian School Association. In the event tuition is not paid, legal means of tuition collection may be used.
4. I/we understand that if I need to withdraw my child from Kalamazoo Christian Preschool, the registration fee is **non refundable** and not applied to tuition owed. I/we will provide at least a two week notice before his/her last day. Tuition will be pro-rated. I/we will pay tuition for the days my child attended. If a two week notice is not given, I/we will forfeit pro-rated tuition.
5. I/we have read and affirm the Enrollment Standards on the reverse side of this form.

GENERAL INFORMATION

- Kalamazoo Christian Schools work in partnership with Christian families and the churches they attend. By the kindergarten year, a pastor's recommendation is required as part of the enrollment process (not required for preschool).
- We believe that parents should consistently teach and model Biblical principles and that unmarried, live-in partnerships, whether heterosexual or homosexual in nature, are not aligned with the Biblical mission of our schools.
- The Kalamazoo Christian School Association is controlled by an elected Board of Trustees. Board members are parents and friends committed to training children in keeping with the teachings of the Holy Bible, as interpreted in the Reformed Standards

STATEMENT OF BASIC BELIEFS AND PURPOSES (adapted from registration contract for K-12 students)

1. I believe that God exists in three persons, namely, God the Father who is the creator and sustainer of the universe. God the Son who became incarnate in Jesus Christ to save sinners who believe in Him and who now rules as King of the universe and the universal church; and God the Holy Spirit who was sent as the Christian's comforter, sanctifier and guide.
2. I believe that the Holy Bible is the only infallible and inspired Word of God and that it must be taught and used as the guide for the Christian's life and conduct.
3. I believe that the Word of God requires Christian parents to make every effort to train their children in the fear and nurture of the Lord, and that for this reason, the instruction of children in the school as well as in the home must be in keeping with the teachings of the Word of God.
4. I believe that the right and responsibility to train children belongs to parents and that these schools depend on and belong to the parents rather than the church or state.
5. I believe we must help our students understand that God summons them to honest worship, moral discipline and personal holiness and that we must equip them for meaningful service in the Kingdom of God.
6. I believe that students enrolled in Kalamazoo Christian Schools and their parent(s) shall be associated with and regularly attend a Christian church.
7. I believe that the Kalamazoo Christian Schools shall meet the academic standards of the state both in respect to academic requirements for faculty and administration and in terms of offering the basic curriculum to enable the student to contribute to the general welfare of the state and the society in which (s) he lives.

PARENT/GUARDIAN AGREEMENT

1. I agree that I am enrolling my child(ren) in the Kalamazoo Christian Schools primarily because of my earnest desire that my child(ren) receive Christ centered academic training.
2. I want my child(ren) to be educated in a manner consistent with the Statement of Basic Beliefs and Purposes of the Kalamazoo Christian Association.
3. I agree that, as a parent, I will support the schools in their efforts to provide education that is distinctively Christian and that I will seek to uphold and maintain the fundamental unity of the schools and the home.
4. I understand that the personal conduct of all students must conform to school standards. If disagreement exists, I will have an opportunity to discuss such matters with faculty, administrations, and board members.
5. I understand that enrollment is subject to the governing authorities of the Kalamazoo Christian School Association, which reserves the right to accept or reject any applicant.
6. I understand that the Kalamazoo Christian School Association admits students of any race, color, or national/ethnic origin to all rights, privileges, programs and activities generally made available in the schools. I further understand that the Kalamazoo Christian School Association does not discriminate on the basis of race, color, or national/ethnic origin in the administration of educational policies and admission.

Set up your FACTS account for automatic payments between June 1 and (no later than) July 25.

On the front page of our website there is a direct link to FACTS (picture below shows the front page of the website). You will need your bank routing and account number to set up your automatic payments. Once you have set your account up, KCSA will go in and enter your tuition amount (no later than July 30) and then your payments can begin. Preschool payment plan is 10 months (or less), August through May. K-12 payment plan is 12 months (or less) August through July. If your child starts preschool after school has begun, the number of payments allowed will be less than 10 months.
